

SWIMGA TAX EXEMPT ACCOUNTS

FOR VARIOUS STORES IN EVANSVILLE AND SURROUNDING AREA

There are many stores in the Tri-state area that offer SWIMGA tax exemptions. Be sure to tell the cashier that your purchase is for SWIMGA so you do not have to pay sales tax. Some tax-exempt numbers are filed under Master Gardener's names or addresses, instead of SWIMGA.

If the store does not have a Tax-Exempt number on file for us, set it up under SWIMGA, Southwestern Indiana Master Gardener Association, or under the phone number for the Extension Office (812-435-5287). Complete/sign the IN Sales-Tax Exemption Form ST-Form105 and submit to the appropriate store personnel. Some businesses have their own ID code and will give SWIMGA a unique ID number.

- **BIG LOTS** – Town Center Diamond Avenue – 00418324. We are filed under SWIMGA.
- **BUEHLER'S IGA** – 2220 E Morgan Avenue – 063001157
- **COLONIAL CLASSICS LANDSCAPE & NURSERY** – 3633 Epworth Rd, Newburgh. SWIMGA purchases receive 25% discount; SWIMGA member purchases receive 20% discount. YOU MUST SHOW YOUR SWIMGA MEMBERSHIP NAMETAG TO RECEIVE EITHER DISCOUNT.
- **DOLLAR GENERAL** – Any location in Indiana. Must have the *Dollar General Tax-Exempt Approval Notification* form with you whenever making a purchase. Our tax ID number is embedded in the barcode on the form. This form is on our website under Member Resources.
- **FAMILY DOLLAR STORE** – Town Center Diamond Avenue – They require a copy of the Indiana tax exempt certificate that they will scan.
- **FELTS LOCK SHOP** – 4000 E Indiana St -
- **FRAMING AND FLORAL GALLERY** – West Franklin Street – 063001157. We are filed under “Southwestern Indiana Master Gardeners Association”. They will waive the taxes and also give you a 10% discount.
- **GFS MARKETPLACE** – Burkhardt Road -- 300000000044238 – President has an ID card.
- **HARBOR FREIGHT TOOLS** – 1200 N Willow Rd - SWIMGA
- **HOME DEPOT** – under 812-435-5287 - Southwestern IN Master Gardener Assn.
- **LOWE'S** – under 812-435-5287 - also use our number – 063001157. Next renewal due 4/9/23.
- **MENARDS** – East side, just off Green River Road – IN0191319 or IN0151122. Use the barcodes on the Menards form. See instructions on form if told tax exemption needs to be renewed. Password is “SWIMGA20”.
- **OFFICE DEPOT** – Customer ID# 69644608 – SW Indiana Master Gardener Evansville, IN
- **ROOTED BARREL, THE** – 610 E Hillsdale Rd
- **RURAL KING** –Morgan Ave. and at Diamond & St Joseph - under 812-454-2958
- **RYAN'S ACE HARDWARE** – 7844 W State Rd 66, Newburgh
- **STAPLES** – 235 N Burkhardt Rd - under 812-435-5287
- **SUPERIOR AG** – 5015 St Joseph Rd – under SWIMGA
- **TRACTOR SUPPLY** – 5210 E Morgan Ave – under 812-454-2958
- **VARIETY VILLAGE** – 600 E Columbia St – Must be renewed annually by May 30th
- **WAL-MART** – All IN locations – 1936004 - filed under Southwestern IN Master Gardener. Go to the Service Desk and get a card. Keep the card and use over and over again at any location.
